<p>2. Hazards identification</p> <p>AIREX® R82 does not constitute any risk to public health and environment if it is used as intended.</p> <p>Fine dust is produced while sawing, milling, grinding and sanding.</p> <p>Irritant fumes may be produced while thermoforming.</p>
<p>3. Composition / Information on ingredients</p> <p>Rigid polymeric foam on the basis of Polyetherimide (PEI), foamed using non ozone depleting blowing agents.</p> <p><i>Further ingredients:</i> Residual solvents (< 1%) (non halogenated organic solvents).</p>
